

**OFFICIAL CONTEST RULES
INNSBROOK WEDDING GIVEAWAY**

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND
WILL NOT INCREASE YOUR CHANCES OF WINNING**

I. ELIGIBILITY: **NO PURCHASE IS NECESSARY TO ENTER**; contest is open to legal residents of any one (1) of the forty-eight (48) contiguous continental United States or the District of Columbia (Excluding Alaska, Hawaii, Puerto Rico, all U.S. territories and possessions and overseas U.S. military installations) who are eighteen (18) years old and over. Employees and families of Innsbrook Corporation, its affiliates and participating sponsors and their affiliates are not eligible to win.

II. GENERAL PRIZE INFORMATION: One winning couple will be chosen. Prize winners must present valid identification and proof of age to claim prize. Winner is subject to state, local, and federal taxes where applicable. If for any reason the winner is unable to utilize the prize on the dates given, subsequent draws will be made until a qualified winner is drawn.  - An officiant (Rob Cutler) to perform the ceremony provided by The Edge – DJ Productions. (Valued at \$650)
 - DJ entertainment for reception provided by The Edge – DJ Productions. (Valued at \$1,200)
 - Wedding Cake or Cupcakes for up to 175 guests provided by Jilly’s Cupcake Bar, LLC. (Valued at \$1,200)
 - \$350 Gift Certificate for Vintage Décor rental for ceremony or reception provided by Worn Vintage. (Valued at \$350)
 - Chair Covers with Sashes for reception provided by Big Red Events. (Valued at \$1,000)

 - Ground transportation provided by Gem Transportation LLC to be used the day of the wedding. Vehicle type based upon availability. (Valued at \$832)
 - Bridal Hair & Makeup for the bride, plus up to five wedding party members (excludes airbrush, eyelashes and trial runs) provided by Wild Kat Weddings (a division of Wild Kat Hair Salon & Tan, LLC). (Valued at \$610)
 - Engagement photo session with DVD and copyright release provided by Excellence in Photography. (Valued at \$200)
 - Fireworks display provided by J&M Displays, Inc. (Valued at \$2,000)
- Wedding bouquet preserved and enclosed in an 8”x12” table dome provided by Suspended In Time. (Valued at \$189)

Note: Gratuity and taxes are not included with any prize element and are the responsibility of the prize winner.

V. VERIFICATION OF POTENTIAL WINNER: Potential winners must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winners may be required to provide the Innsbrook Corporation with documentation that shows he or she was an eligible participant. The potential winner will be
