

OFFICIAL CONTEST RULES
INNSBROOK WEDDINGS TOUR & WIN GIVEAWAY

I. ELIGIBILITY: NO PURCHASE IS NECESSARY TO ENTER; contest is open to legal residents of any one (1) of the forty-eight (48) contiguous continental United States or the District of Columbia (Excluding Alaska, Hawaii, Puerto Rico, all U.S. territories and possessions and overseas U.S. military installations) who are eighteen (18) years old and over. Employees and families of Innsbrook Corporation and its affiliates are not eligible to win.

II. GENERAL PRIZE INFORMATION: One winner will be chosen. Prize winners must present valid identification and proof of age to claim prize. Winner is subject to state, local, and federal taxes where applicable. If for any reason the winner is unable to utilize the prize on the dates given, subsequent draws will be made until a qualified winner is drawn.
